HelpAge continued to conduct trainings for staff and network members on collection and analysis of data using the Washington Group Questions (WGQ). Rolled out the Rapid Needs Assessment for older persons for during several emergencies and has reviewed the data tools to be more inclusive. This raised awareness among HelpAge staff and network members about the need for data on disability and ways to produce this data.  Specifically, the progress includes:  COVID-19 rapid needs assessments conducted during February 2020 — October 2021 collected data on the situation of older people with disabilities.

1.2	What areas of your Inclusive data priorities/ IDC Action Plan have you made the least progress on, in the past year?	Include any challenges or barriers faced.	HelpAge has been hampered in engaging with other stakeholders on inclusive data via the Titchfield City Group on Ageing Statistics; joining the LNOB Partnership with ICSC and the Making Voices Count project (focusing on community-driven data on SDGs) with our Malawi Network Member joining the national coalition; and producing a Technical Note on "Breaking the Breaking through the 60+ ceiling: assessment of disaggregation of the SDGs indicators on older people using household surveys".  Wider engagement with external stakeholders beyond these data initiatives has been hampered by reductions in staff capacity following the restructuring process the institution has undertaken and resource constrained as a resulting from of the COVID 19 epidemic.
